TO GLOBAL.

TLA is recognised around the world as the superior modifier for refinery bitumen. It is used in a number of applications worldwide, and meets market specifications in the United States, under the Strategic Highway Road Programme (SHRP), the American Society for Testing and Materials and by the Federal Aviation Authority. In the United Kingdom, specifications for TLA have been met under the British Standard Institute (BSI); in Japan TLA has achieved specifications for use on bridge decks and in the People's Republic of China, for use on highways and airports.

Lake Asphalt manufactures and markets a range of Cationic Bitumen Emulsions produced in its state-of-the-art Bitumen Emulsion Plant and a TLA Pelletization Plant. The Company is also a distributor of Refinery Bitumen, a range of coatings that use TLA as a base branded under the LASCO Range of Products, and a mixture of TLA and Refinery Bitumen known as TLA Blend (AC).

Lake Asphalt markets the world famous Trinidad Lake Asphalt (TLA) Pelletized TLA (pTLA), five types of bitumen emulsions, bitumen and the Lasco Range of products

Lake Asphalt distributes TLA to China, Nigeria, Japan, Germany, UK and the USA.



Through our distributor in the United Kingdom, TLA has been sold into the copper minds of Chile, the massive asphalt roofing industry of South Africa and New Zealand and specified for bridge deck works in Japan and Hong Kong. While we have continued to service these markets we have developed new product combinations that will meet specific application needs.

China today is the largest market. We have also shipped pelletised TLA commonly referred to as pTLA to Germany, India, Brazil and TLA Cold Mix to Nigeria, India and Brazil.

Regionally, airports in Grenada, Guyana, St Lucia, Barbados, and Jamaica all have been paved with TLA. In addition, we provide bitumen and bitumen. Emulsion products in the region for road construction.

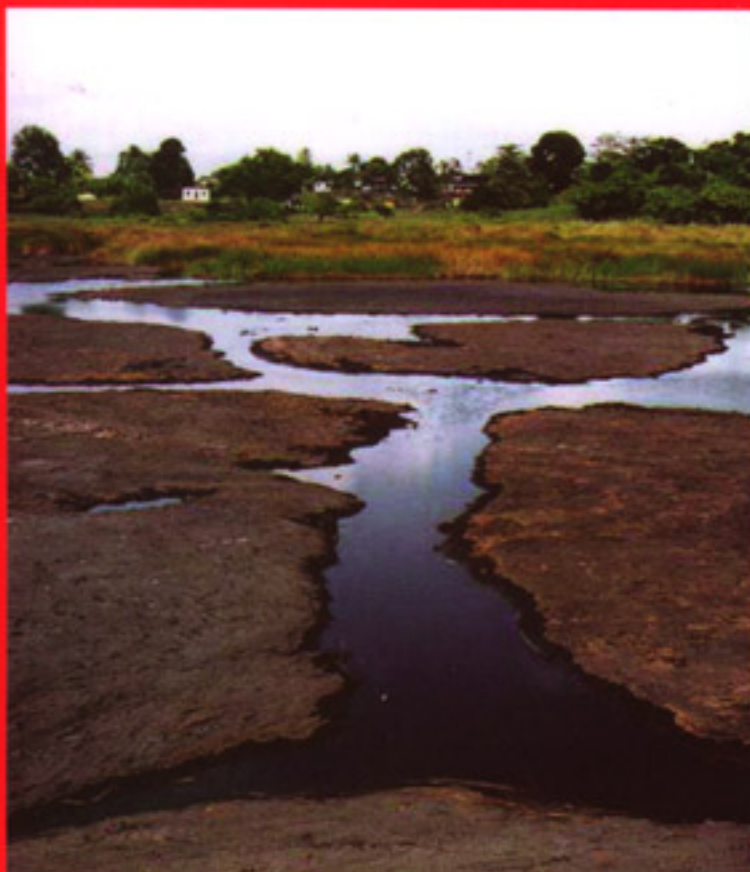
